
## Sunrise industries and the reemergence of European leadership


### The primacy of ecology

Primary raw material production will always be necessary to bridge the demand shortfall. And there will always be mineral raw materials that cannot be recycled, creating the need for reliable supply to underpin the sovereignty of Europe and its industry.



## Made in Europe

European industrial value chains are the key to preserving our competitiveness and prosperity. Especially during the post-pandemic recovery, it will be imperative that investments and subsidies from the EU recovery fund promote value creation "#MadelnEurope". The Covid-19 crisis has highlighted the vulnerability of our supply chains and raised concerns about security of materials supply – namely their availability and cost. Since recycling efforts will not be sufficient to meet demand, the supply of primary raw materials is indispensable. This points towards the need for a combined approach: fostering a circular economy while also emphasizing the importance of primary raw materials.
